PATROL OPERATIONS DIVISION

Patrol Operations is comprised of 16 sworn officers under the leadership of **Captain James Shelhorse**. Officers are assigned to one of four squads, each led by a Sergeant, working 12-hour shifts. Patrol Operations handles all dispatched calls for service, conducts self-initiated enforcement activities and provides high visibility patrols in hopes to prevent and deter criminal activity.

STAR Corridor Update

Officers handled **3** calls for service in this area; completed **40** park, walk and talk activities as well as **14** hours of traffic enforcement and general observation time. Officers had **18** community contacts and conducted **3** roll call meetings.

Patrol Highlights

On September 3, officers were notified of a disorderly passenger on an Amtrack Train. Officers responded to the 100 block of North Railroad Avenue and located the suspect who was arrested for public intoxication.

On September 9, officers were dispatched to a call of a suspicious person in the 200 block of Archie Cannon Drive. Upon completion on the investigation, the suspect was located and arrested for indecent exposure.

On September 10, officers responded to the 100 block of North Cottage Green Drive for an abandoned vehicle. Upon completion of the investigation, the vehicle was found occupied and the occupant was arrested for being intoxicated in public and for assault on law enforcement.

On September 18, officers responded to the 100 block of Winter Oak Drive for a call for service. Upon completion of the investigation, a subject was arrested for malicious wounding.

On September 23, officers observed a known wanted subject in the 400 block of England Street. The subject was arrested for an outstanding warrant and possession of a controlled narcotic.

On September 28, officers responded to the 300 block of South Center Street for a call for service. Upon completion of the investigation, a subject was arrested for strangulation and domestic assault.

SPECIAL OPERATIONS DIVISION

Under the command of Special Operations Division, the **Investigative Unit** is comprised of three investigators led by **Captain Marie Kemp**. This operational component is responsible for the investigation of all felony and serious/repeat misdemeanor offenses reported to the police department. Additionally, this unit is tasked with proactive investigations into narcotics trafficking and other criminal behavior.

Investigative Highlights

On September 3, investigators obtained a grand larceny warrant on a subject who unlocked a game of chance machine and stole money. This incident occurred in the 10000 block of East Patrick Henry Road. Investigators worked with a surrounding jurisdiction and were able to arrest the subject.

On September 16, investigators obtained a grand larceny warrant for a subject for motor vehicle theft. The vehicle was stolen from the 300 block of Thompson Street. Investigators worked with a nearby jurisdiction to locate and arrest the subject.

On September 26, investigators obtained one contributing to the delinquency of a minor warrant for a subject. This case involved an adult that was having a sexual relationship with a juvenile. Unfortunately, the warrant has not been served as the subject remains at large.

Investigators obtained and processed 14 court orders to obtain digital evidence needed in multiple pending cases.

This month investigators received training in Active Aggressor Response, Cellebrite Recertification, and Supervisor Training for Trauma Informed Policing/and Self-Care for Officers.

SPECIAL OPERATIONS DIVISION

Under the command of the Special Operations Division, the **Crime Prevention/Logistics Unit** entails several functional components of the agency: Crime Prevention (1 officer), and the Auxiliary Unit (1 volunteer officers) and civilian volunteers all led by **Captain Marie Kemp**. In addition to duties tasked to individual members, this component is responsible for Recruitment, Selection, Training, Public Information, Special Event Coordination, and IT Administration.
